International Registration Plan (IRP): Full Reciprocity Plan (FRP) Ballot has Passed

What Does this Mean:

- Full Reciprocity is effective January 1, 2015 for all IRP member jurisdictions.
- Cab Cards will now show all IRP member jurisdictions.
- Distance submittals must only contain **Actual Distance** accumulated in all jurisdictions for entire fleet.
- **Average Vehicle Distance (AVD)** may be submitted to reflect intended distance in all jurisdictions for entire fleet only when no actual distance was accumulated during reporting period of July 1st - June 30th.
- Fleets may only report either all actual distance or all average vehicle distance during fleet renewals.

Benefits:

- Elimination of the need to Add States continuously throughout the registration year.
- There will no longer be the need for multiple International Registration Plan fleets.
- Interstate registration authority and reciprocity in all IRP member jurisdictions.
- Elimination of estimated distance submittals and estimated distance fees.

Who is Affected, When, and How:

- IRP fleets with effective dates beginning January 1, 2015, or later.
- If you are a new carrier without distance from prior reporting period, you will pay fees based on Georgia's average vehicle distance (AVD) chart.
- Renewal fees will be charged based on the fleet's actual distance during reporting period.
- Fleets expiring November 2014 or prior "old rules" will continue to apply.

Renewal Information to Keep in Mind:

- International Registration Plan renewal packets are sent three months prior to plate expiration month. Please keep in mind that if you have not received your IRP renewal notice, it is still your responsibility to file renewal timely.
- There is a 10% late filing penalty towards renewals received after filing deadline.
- There is a 25% late payment penalty assessed towards renewal invoices paid after payment deadline.

Georgia Specific Implications:

IMPORTANT: *Discontinuation of Georgia's "Restricted" IRP fleet category.*

What Does this Mean for People who Have Restricted Plates?

- Elimination of "Restricted" IRP fleets.
- Elimination of Cab Cards which reference restricted commodities and/or "IR" plates.
- Elimination of IRP Cab Cards which only list "Georgia" on the face of Cab Card registration.
- Elimination of IRP license plates that currently begin with "IR" and/or list "Restricted."
